
NOTICE OF OBJECTION
Pursuant to N.C.G.S. §20-139.1

Now comes Marcus E. Hill, attorney and hereby gives notice to the Court and the State of the defendant's objection to the use of any chemical analyst's report or affidavit or any other laboratory report or chain of custody documents regarding the chemical examination of the alleged alcohol or controlled or impairing substance content of defendant's breath or blood or analysis of any alleged controlled substance in this case without a proper evidentiary foundation introduced at trial through witnesses with personal knowledge.

This notice of objection is made pursuant to N.C.G.S. §20-139.1. Accordingly the State is hereby placed upon notice that a traditional evidentiary foundation will be required at trial in order to use this material, and that any such evidence must be introduced through witnesses for whom the defendant shall have the opportunity to confront and cross-examine pursuant to the 6th Amendment to the United States Constitution.
